**Articles of Organization**

(General Laws, Chapter 180)

**ARTICLE I**

The exact name of the corporation is:

**ARTICLE II**

The purpose of the corporation is to engage in the following business activities:

THE FLETCHER MAYNARD ACADEMY PARENT TEACHER ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE AND EDUCATIONAL PURPOSES UNDER SECTION 501(C)3 OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTIONS OF ANY FUTURE FEDERAL TAX CODE. AS PERMITTED UNDER SECTION 501(C)3 ITS GOALS INCLUDE BUT ARE NOT LIMITED TO: 1) ESTABLISH AND MAINTAIN A WORKING RELATIONSHIP AMONG PARENTS, SCHOOL AND COMMUNITY 2) SUPPORT SCHOOL IMPROVEMENT TEAMS AND PROMOTE THE FINEST EDUCATION POSSIBLE FOR THE STUDENTS AT THE FMA 3 EXPAND TECHNOLOGY AND SUPPLEMENT SCHOOL EQUIPMENT AND SUPPLIES 4) INCREASE STUDENT SAFETY AND SECURITY 5) DEVELOP PROGRAMS AND PROJECTS THAT WILL SUPPORT OR ENRICH CURRICULUM 6) ENHANCE THE QUALITY OF EDUCATION BY RAISING FUNDS FOR SCHOOL AND CLASSROOM SUPPLIES AND PROGRAMS AT INITIATIVES THAT FALL OUTSIDE THE SCHOOL BUDGET.

**ARTICLE III**

A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of election or appointments, the duration of membership and the qualifications and rights, including voting rights, of the members of each class, may be set forth in the by-laws of the corporation or may be set forth below:

**ARTICLE IV**

Other lawful provisions, if any, for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its directors or members, or of any class of members, are as follows:

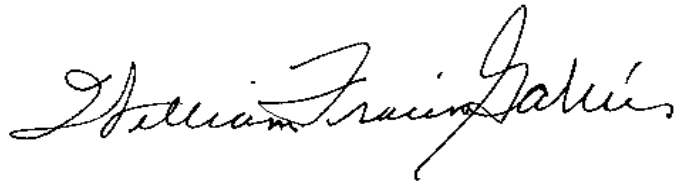
